Some problems may arise from sheer carelessness and overwork, while others may arise from hiring staff that are genuinely unqualified and abusive.

Elder neglect or abuse encompasses a variety of ill-treatments, including physical and emotional abuse as well as sexual abuse, neglect, and financial abuse. Abuse or neglect may not be due only to nursing home staff; in-home caregivers and even family members have been known to abuse the elderly. One common form of abuse perpetuated by family members is financial abuse; this may be very difficult to detect unless you have intimate knowledge of family finances.
